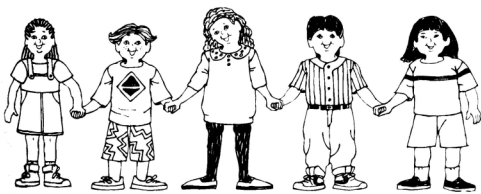

Separation of church and state is carefully maintained. We use available buildings and fire halls that are within walking distance or a short bus ride from the school. Class schedules are arranged with the principal of each school.



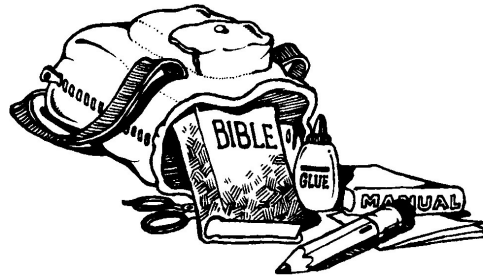
What is Released Time?

Residents of Pennsylvania have a State Law that provides for a child to be excused from public school for the purpose of religious instruction. It is known as the "Released Time Law," and permits a time period, not to exceed 36 hours per school year, for religious instruction. The class time is thus designed to cover one class period per week and consists of a Bible lesson, scripture memorization, songs, and review games. There will be no cost to you or the school district. The classes are Bible based and are open to all children regardless of race, color or national origin.

What Will My Child Be Taught?

The Bible is the textbook. The curriculum is designed to help the students:

- ⇒ gain a working knowledge of the Old and New Testament, its stories and principles for life.
- ⇒ develop right attitudes for daily living, and a sense of relationship to God.
- ⇒ gain knowledge that will stimulate a renewed interest in other school subjects.
- ⇒ act as a responsible Christian citizen who will express the love of God at home, at school and at play.
